# Level, Campus, Lifestyle & Student Type

Student groups in the Norwich population can be categorized based on academic program (e.g., College, Major, and Degree) or demographic attributes. Other attributes considered when studying the population include:

<u>Level</u>: Undergraduate (UN) or Graduate (GR)

<u>Campus</u>: Northfield (N) or Distance Learning (DL)

<u>Lifestyles</u> of On-Campus Undergraduates, Degree-Seeking and non-Degree-Seeking

- Corps of Cadets (LSM & LSMD)
- Civilian Commuters (LSD)
- Civilian Residents (LSR)
- Non-Matriculants (LSE & LSN)

#### Student Type

- Primary Classifications are Continuing ('C'), New ('N'), Transfer ('T') & Re-Admit ('R')
- Secondary Classifications include Dual Enrollment ('H'), Early College ('I'), & Non-Matriculating Continuing Ed ('E')

## IPEDS Reporting and Census Days


#### **IPEDS Reporting**

- The Integrated Post Secondary Education Data System (IPEDS) is part of the National Center for Education Statistics (NCES), the primary federal entity for collecting and analyzing data related to education in the U.S. and other nations.
- NCES is located within the U.S. Department of Education and the Institute of Education Sciences. NCES fulfills a Congressional mandate to collect, collate, analyze, and report complete statistics on the condition of American education.
- IPEDS provides a variety of data from all public and private institutions in the U.S. and outlying areas that are eligible to receive Title IV funding. Institutions collect and report that data three times during an academic year [ref. *College Navigator*].


#### Census Days

- Once each Fall and Spring semester, as part of IPEDS reporting, the Office of Institutional Effectiveness collects institutional enrollment data on a designated census day.
- The Fall 2025 Census Day is October 31.


# Fall Census Day Enrollment Counts, 2020 - 2025

## Persistence, Retention, and Re-enrollment

**Retention** is an institutional measure that reflects the university's ability to re-enroll students from one semester to the next.

For this presentation, retention refers to degree-seeking first-time students who began in the fall and returned for the following fall semester. Note that "first-time student" includes those who earned college credits while in high school (Early College/Dual Enrollment)

**Persistence** is a student-centered measure that reflects a student's motivation and ability to continue their enrollment through to graduation.

Here, *persistence* represents degree-seeking non–first-time students (including new transfer students, continuing students, and readmitted students) who enrolled in the fall and returned for the following fall semester.

**Re-enrollment** refers to the act of a student registering for a subsequent term.

Put simply, it combines our definitions of *retention* and *persistence*—students who continue their studies, whether they are first-time or returning.

In this context, re-enrollment does not include stop-out students who later return.

For this presentation, re-enrollment represents all degree-seeking students and whether they reenrolled for the following fall semester.

## Persistence, Retention, and Re-enrollment

#### BUT...!

#### ...some caveats


Graduated students are not expected to re-enroll and are therefore excluded from the calculation.

Students who do not register for classes in the following fall, whether due to holds, academic suspension, withdrawal, leave of absence, or other reasons, are included in the calculation.

**Things to watch out for**: Small population sizes (On-campus GR students, CGCS New Students, etc.) will create some wacky re-enrollment rates.

#### 5 Years of Fall Term Retention Rates






Fall 2024-to-Fall 2025 overall retention rate is almost exactly equal to the 5-year average of retention rates over the past 5 years (74.07%)

## 5 Years of Retention Rates by Minority Status


#### **Retention by Minority Status**



First-Time Minority student retention has increased since its low two years ago. Overall, retention have declined among both minority and majority students.

# 5 Years of Retention Rates by Sex




Both male and female First-Time students have seen a decline in retention rates since Fall 2019, although females are seeing a slight uptick over the past two years.

#### New Student Retention Rates by Lifestyle





Retention rates for students in the Corps of Cadets have remained relatively stable over the past five years, though they have declined from their highest mark last year. Civilian rates have increased since their low two years ago.



#### Fall 2024 to Fall 2025: Who Didn't Retain?

First-Time Females in the Corps: usually a pretty 'steady' group, retention wise, has seen a steep decline in the past two years.






Retention rates for First-Time Male Civilians have declined, with the largest decrease in Fall-2024-to-Fall 2025 observed among majority students.

# 5 Years of Retention Rates by Campus and Level






Retention rates for On-Campus undergraduate "New" students (First-Time students and New Transfers) have declined, while CGCS undergraduate and CGCS graduate retention rates have remained relatively stable.


#### Other Factors: Fall 2024 to Fall 2025

Not surprisingly, the more DFWs a student earns, the less likely they are to re-enroll. What *is* a surprise is the significant jump between 1-2 DFWs (77.36%), and 3-4 DFWs (54.55%). The decrease is even more stark when counting the number of DFWs earned in Gateway courses

#### Re-enrolled by # of DFWs




#### Non-Athlete Civilian Males Struggle to Retain



Male, Non-Athlete, Civilian students show some of the lowest retention rates, suggesting potential challenges with campus connection and engagement

# Fall-to-Fall Re-Enrollment Rates, 2020-2025


#### **Re-Enrollment Rates**



Although retention rates are volatile, Norwich's on-campus reenrollment rate is quite steady—an invested student is a returning student.


#### Fall 2024 to Fall 2025: Who Didn't Re-Enroll?


The table summarizes the number of graduates (UN) by calendar year (2019 through 8/26/25).

Defined as the percentage of each cohort that graduates within six years of matriculation. (Four-year and eight-year graduation rates are also calculated, but six-year graduation rates are used in most contemporary analyses.)

## Six-Year Graduation Rates, 2019-20 Academic Year to 2024-25 Academic Year





## **Highlights**

- Since Fall 2020, Total Student Enrollment has declined 23.57% decline in Total Enrollment and On-Campus Degree-Seeking Undergraduate Enrollment has declined 24.28%. Graduate student enrollment has declined 35.59% since Fall 2020.
- Since Fall 2019, annual First-Time Full-Time (FTFT) Degree-Seeking Undergraduate Retention rates have ranged from 67.43% to 79.37%. Retention rates for Cadets are consistently higher than retention rates for Civilians. Re-enrollment rates for Civilian Male Undergraduates have been sharply down recently. Norwich's FTFT Retention rates are consistently lower than the IPEDS Comparison Group Median.
- Although retention rates are volatile, since Fall 2019 Norwich's on-campus re-enrollment rate is quite steady (~80% Fall-to-Fall). However, the more DFWs a student earns, the less likely they are to reenroll.
- The 6-Yr Graduation Rate for Undergraduates has trended slightly upward since Fall 2020. Civilian UN 6-Yr Graduation rates have lagged Corps of Cadet 6-Yr Graduation rates. Norwich's 6-Year Graduation rates are consistently lower than the IPEDS Comparison Group Median.
